- (a) The Bayside Leader of 5 April 2011 reported that the Mayor and two Councillors (Long and Frederico) are scheduled to attend the Australian Local Government Association Conference in Canberra in June of this year at a cost of \$7500. Was this amount included in the Budget and if so, on what page?
- (b) What are the benefits to the Bayside Community having three Councillors attend this Conference?

Response

- a) The cost of attending the conference is allowed for within the budget for the Governance Department in the 2010/2011 budget.
- b) The National General Assembly of Local Government is the premiere local government event bringing together around 700 representatives from councils across Australia to develop local government policy, meet with key federal politicians and hear from renowned experts on key issues affecting local government sector in Australia. The theme of this year's conference is Growing with our Community: Place, Position and Partnership, and is aimed at stimulating delegates to develop new ways of better meeting the needs of local communities.

It is not unusual for more than one Councillor to attend this event. There is an additional council report on tonight's agenda recommending the attendance of Cr Cooper Shaw.

2. Mr Kevin Spencer

As stated in the Bayside Community Plan, its purpose is "to work with the community to make Bayside a better place to live" We will increase transparency and ensure our approaches to community engagement are appropriate, ongoing, open etc. Why then does council continue with its secretive Assembly of Councillors meetings, (Six (6) listed tonight) that curtail community involvement and lack of public debate. When looking at the Implications of such restrictive meetings under the various headings such as Policy, such meetings held in camera are contrary to councils Community Plan Policy, with the legal/statutory requirements fail to show the location of the assembly. The financial & Resources Implications state there are no financial & Resource implications. This is an understatement when considering the venue costs, and finally the Social Impacts that disadvantage the community by holding such covert meetings that bring about further disenchantment of council by members of the Bayside community.

A. Bearing in mind this closed meeting travesty and the pledge by council to be open and transparent with its community, will council cease this unnecessary practice and include all future items from such meetings at Ordinary Meetings of council, with genuine confidential items treated as pursuant to Section 89(2) of the Local Government Act 1989, in the interest of real Community Engagement.

Response

- a) Assemblies of Councillor briefing sessions for providing Councillors with necessary background information on various matters. These briefing sessions unlike an Ordinary Meeting of Council are for information purposes only and are not a decision making forum. In order to ensure decisions are made based on up to date information and the smooth running of council meetings in a timely manner, it is necessary to provide the relevant information to Councillors prior to the Ordinary Council meeting. Assembly of Councillor matters are provided for under the Local Government Act and Bayside City Council's Assembly of Councillors. They are an accepted part of a framework of Good Governance.

3. Mr Kevin Spencer

Like bees to the honey pot the Australian Local Government Association (ALGA) is once again holding its assembly in Canberra June this year. Under Financial & Resources Implications council states "that the cost associated with the attendance & travel of the Mayor at the national assembly is provided in the current 2010/2011 Budget.

- A. As the Mayors costs only are provided for in the Budget, will the three councillors be paying their own costs? Which on estimation is well over \$10,000 for four (4) councillors including the Mayor. If not, will the ratepayers of the City of Bayside be getting value for money by this unnecessary cost burden brought on by the financial cost of three extra councillors.
- B. Will all councillors attending make separate public reports on their understanding of deliberations from the ALGA meeting effectual to the City of Bayside to justify their attendances.

Response

- a) The authors statement regarding the Mayor's costs are inaccurate. The budget for 2010/2011 has provision for Councillor development which incorporates expenditure for Councillor attendance at the ALGA. Attendance is considered to be of significant benefit to Councillors and to Council.
- b) A combined report on attendance, provided by the Mayor would be considered sufficient, but individual Councillors may wish to provide their own report.
